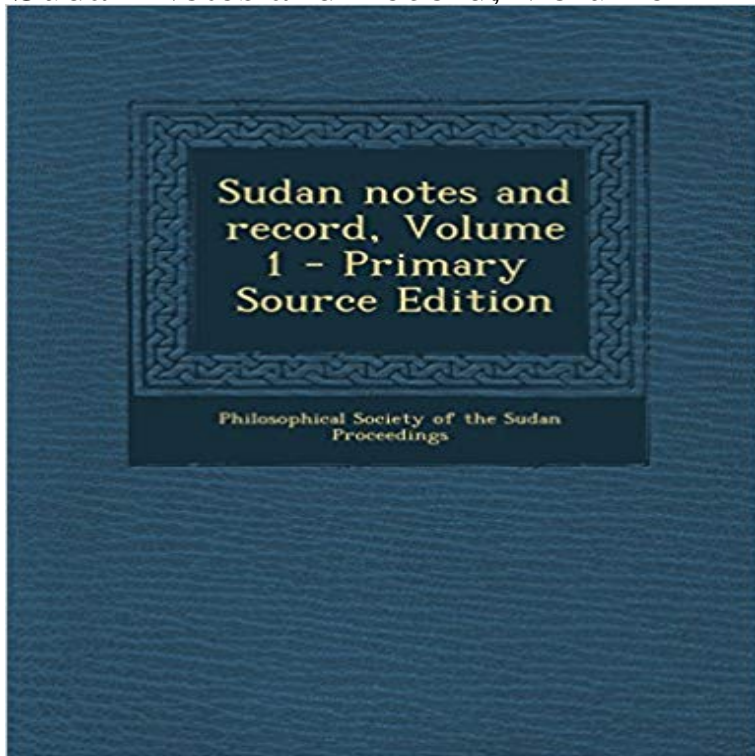


Sudan Notes and Record, Volume 1 - Primary Source Edition
